**APPLICATION FOR PERMIT TO SELL AGRICULTURAL, VEGETABLE,
AND/OR FLOWER (WILDFLOWER) SEEDS**

The Nebraska Seed Law requires that any person who labels for sale in Nebraska any agricultural, vegetable, or flower (wildflower) seed shall be required to obtain a seed permit. The annual registration fee for this permit is based on the number of pounds of seed the applicant labeled and sold during the preceding calendar year. Permits are required to be renewed on or before January 1 of each year. **A delinquency fee of 20% per month of the amount of the fee due is assessed for all permits not renewed by January 31.**

Using the following chart, please calculate the appropriate fee due from your firm. Return the application along with the fee to our office. A permit will be issued to you after the application has been processed.
