## APPLICATION FOR EMERGENCY USE EXEMPTION DISTRIBUTION PERMIT, 2025 USE SEASON GOLTIX 700 SC on Sugarbeets

The applicant herein acknowledges and understands that this permit authorizes the distribution, by that person, of the indicated pesticide for **control of glyphosate resistant Palmer amaranth in sugarbeets in Nebraska counties: Banner, Box Butte, Chase, Cheyenne, Dawes, Deuel, Garden, Keith, Kimball, Morrill, Perkins, Scotts Bluff, Sheridan, and Sioux.** The applicant agrees to strictly comply with the provisions of the label for the product indicated below. This emergency exemption expires August 31, 2024.

## GOLTIX 700 SC (EPA Reg. No. N/A) EPA Label File Symbol: 24NE01

Additional restrictions attached to the use of the above-named product that must be met by the permit holder and the user:

- A single application may be made by ground equipment only, after planting and prior to crop emergence, as a single pre-emergent (PRE) application at 64 fl. oz. Apply GOLTIX 700 SC with at least 10 gallons of water per acre. In the event of crop failure in a sugarbeet field treated with Goltix 700 SC, and that field is replanted to sugarbeets that same season, an additional application of Goltix 700 SC may be applied at 64 fl. oz. product (2.92 lb. ai) per acre no sooner than 20 days after the previous application was made to the initial crop.
- Application by chemigation or aerial application is prohibited.
- > To protect workers, a 12-hour restricted entry interval (REI) must be observed.
- A minimum of three points must be achieved to mitigate runoff from EPA's Mitigation Menu.
- Applications of GOLTIX 700 SC to sugarbeets in Nebraska may take place only from March 30, 2025, through June 15, 2025.
- Any adverse effects resulting from the use of GOLTIX 700 SC such as impacts on birds, humans, fish or wildlife must be reported immediately to the Nebraska Department of Agriculture, telephone number (402) 471-2351.
- Following the use period, any unused product must be returned to the distributor or to ADAMA, and all products must be returned to ADAMA by August 31, 2025.
- Permit holders shall provide the Nebraska Department of Agriculture a final report of all sales, distribution or commercial applications of GOLTIX 700 SC under this exemption. The report shall include the total amount of exempted pesticide distributed or applied. This report shall be submitted to the Department no later than September 30, 2025.

This permit is only valid when approval is signed on page 2 by a representative of the Nebraska Department of Agriculture.
