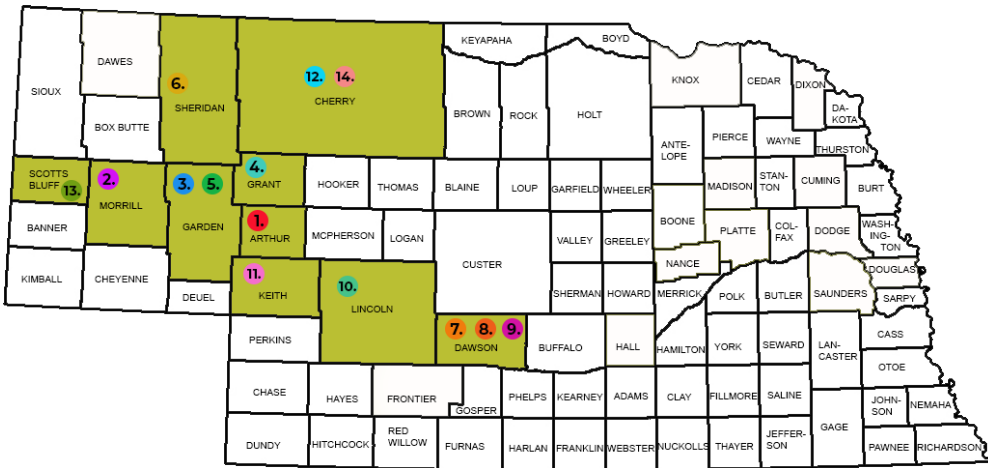


Fencing Supply/Hay Drop-Off/Pick-Up Points

- The **Nebraska Department of Agriculture Disaster Resources website** features all this information, along with a listing of individuals seeking assistance, those willing to donate hay, fencing supplies, trucking, etc. to enable them to make 1 on 1 connections. <https://nda.nebraska.gov/disasterresources>
NDA also offers the **Hay and Forage Hotline** <https://nda.nebraska.gov/promotion/hay> to connect buyers with the sellers of hay, pasture and other types of forage.
- The **Nebraska Department of Transportation** advises if you have an oversized load on the interstate, call 402-471-0034 or email ndot.ntpspermits@nebraska.gov. NDOT will issue a permit for free. There is no central hub of waived weight restrictions by state. Call either the State DOT's or carrier enforcement (varies by state, may be with the DOT or state law enforcement). More info here: <https://bit.ly/DisasterReliefPermits>.
 - **NDOT's Bridge Weight Restriction Map** shows the weight restrictions on ALL bridges. Be cautious of county roads – 511 does not show the county. <https://bit.ly/BridgeWeightMap>
 - **Emergency Oversize/Overweight Permit Executive Order 26 07** permits authorizes motor carriers operating within the State of Nebraska and providing feed to areas affected by the State of Emergency to exceed standard weight limits as outlined below. <https://bit.ly/DisasterReliefPermits>

- **Motor Carrier Relief Executive Order:** Waives hours of service restrictions and adjusts maximum load width/weight limits allowed for commercial motor carriers operating within the state and are delivering feed and other supplies under the ongoing wildfire emergency. **This new order is effective on March 28.**
- The **USDA Farm Service Agency – Nebraska Office** has programs producers may be eligible for. For more information on these programs and documentation requirements, contact your County USDA Service Center or visit fsa.usda.gov/disaster. - **Nebraska Department of Water, Energy, and Environment** will take any carcass disposal questions at 877-253-2603.
- The **Nebraska Veterans Aid Fund (NVA)** at <https://veterans.nebraska.gov/nva> has funding available for veterans, spouses, and dependents that can be utilized for unexpected expenses, including food, clothing, temporary housing, and more.
- **Nebraska Forest Service** can help producers assess damage and plan for renovation of windbreaks and shelterbelts. Contact at Trees@unl.edu or 402-472-2944.
- **Nebraska Department of Revenue** has information about the Damaged Real Property Report, Form 425, which allows impacted property owners to file a request with the county clerk to have their property valuations reassessed to the date of the damage. - The **Nebraska Grazing Exchange** offers a virtual map found: <https://nebraskagrazingexchange.com/> that displays sites where fields are available for grazing as well as livestock producers with animals they are willing to move to grazing sites.
- **USDA's Natural Resources Conservation Service (NRCS)** is available to provide technical assistance during the recovery process through planning and implementation of conservation practices on farms, ranches and working forests impacted by natural disasters.
The **Environmental Quality Incentives Program (EQIP)** can also provide financial assistance to help producers implement conservation practices on land impacted by natural disasters. EQIP signups are continuous and will be available for disaster recovery assistance.
